I agree that I filled out the foster application with all answers truthful and forthcoming. I agree that I read and understand the policies that were attached to the application when I filled it out. I acknowledge that the policies were agreed to when I submitted the application.

I acknowledge that should any behavioral issues or concerns should arise, that I will seek help from G.A.R. I agree that should I have to move from my home, I will surrender said dog/puppy to G.A.R, and not surrender to any other person, shelter or rescue.

I agree that G.A.R can do a follow up in my home after the transfer is complete.

I understand that G.A.R has full ownership of said dog/puppy and if they feel the dog/puppy is being harmed, neglected or used for any purpose other than a family foster pet can reclaim dog/puppy.

I acknowledge that all information that I have provided is true and honest. I agree that should I provide any false information, this contract is null and void.
